May 18, 1997: hundreds of militarized NY state troopers in riot gear -operating as specially formed unit, "I-81 INDIAN Detail" - brutally assaulted hundreds of Haudenosaunee people gathered to discuss issues harming their communities. Du opening ceremony prayer baton wielding police -operating under the instructions to no one and take anyone you can" - began beating and clubbing babies, childred women, men, elders, and Clan Mothers. The brutality included throwing babies out of carriages causing one to require a double legged cast for their injuries. Children assating and arrested included an 11 year old and 14 year old girl who was manhandled as slammed to the ground. This continues to impact the health and and well being of all were present; many live with painful lasting injuries and psychological trauma.
