When requesting personnel files: Proof of death (death certificate, obituary notice, picture of gravestone, etc.) is required in all cases, unless the individual died while in service.

- If proof of death establishes that the individual has been deceased for **more than 20 years**, there are no restrictions on releasing his/her personal information.
- If proof of death establishes that the individual has been deceased for **less than 20 years**, then limited personal information may be released to members of the immediate family (e.g. spouse, parents, siblings, children and grandchildren) **as long as proof of relationship is also provided** (e.g. baptismal certificate, marriage certificate or any other document that clearly demonstrates the relationship).

Extension of time limits

In addition, an extension of time may be required. Subsection 9(1) of the *Access to Information Act* allows the head of a government institution, or his or her delegate, to extend the initial period under the following circumstances:

- The request is for a large number of records or requires a search through a large number of records and meeting the original time limit, under either of these circumstances, would interfere unreasonably with the institution's operations
 - Consultation is necessary and it cannot be completed within the 30-day statutory deadline
 - Notice is given to a third party under subsection 27(1) of the *Access to Information Act*
