**Objet : Adaptive reuse of the former Royal-Victoria hospital site.**

Grand Chief,

The Société québécoise des infrastructures (SQI), in collaboration with the ministère de la Santé et des Services sociaux (MSSS), would like to reiterate its interest in listening to the concerns of the Mohawk Council of Kahnawake regarding the adaptive reuse of the former Royal Victoria hospital located on the southern slope of Mount Royal in Montreal, at 687-835 and 1025 avenue des Pins Ouest.

As mentioned in our previous correspondence, dated August 30<sup>th</sup>, the SQI has received a mandate from the Government of Quebec to revitalize this former hospital complex, including the portion of the site dedicated to the activities of the Allan Memorial Institute.

There have recently been a number of publications in the media regarding the potential presence of burial sites in the area of the Allan Memorial Institute, which may be related to past activities on the site (see attachment). Thus, the SQI and the MSSS, in collaboration with McGill University, would like to address a number of concerns that have been discussed in the public arena. The SQI is positively disposed to receiving any information that would allow it to document the reported details and to collaborate in the development of an action plan.

The MSSS and the SQI have a long-standing relationship with Indigenous peoples and understand the importance of maintaining a relationship of trust between the parties.

(carole.arbour@msss.gouv.qc.ca), responsible for special cases and real estate transactions, at the MSSS to follow up on this offer of collaboration. If needed, the Secrétariat aux affaires autochtones will accompany the SQI and the MSSS in these next steps.
