This lawsuit is precisely to order the defendants to reveal which Indigenous children were admitted to the AMI, as only they have the archives and patient records, provided that they have not been purposefully destroyed.

2. Name the indigenous children who allegedly disappeared while being treated at the AMI between 1954 and 1963.

We know about Morningstar, mentioned in Lana Ponting's affidavit. This lawsuit is precisely to order the defendants to reveal which Indigenous children disappeared after being treated at the AMI, as only they have the archives and patient records, provided that they have not been purposefully destroyed.
